At the traffic circle, keep right and continue on Fork Shoals Road. Turn right on Delaware Street. Continue on Delaware Street. Turn left at Old Taxi Way. Bear right at the “Y” split. You will be at the north end of the runway. Please continue on the runway until you see the parking area. Cones will be set up, so please be observant.
