

Standing Rules

Carolina Corvettes Club Inc,

These Standing Rules have been established to reflect the day-to-day operations of the Carolina Corvettes Club Inc. (CCI) and to supplement the Club's By-laws. The Standing Rules are intended to capture the elements of the Club that are either not appropriate for the By-laws or are somewhat likely to change fairly often. The Standing Rules are also intended to be relatively easy to change, requiring only a simple majority vote during a scheduled business meeting.

CCI is an all-volunteer, non-profit organization consisting of Corvette owners/enthusiasts/ hobbyists gathered around celebrating the history and ownership of America's Sports Car, the Chevrolet Corvette. The purpose of our Club is to promote interest in Corvette ownership, operation of and assisting in encouraging others to participate in the enjoyment afforded with the use and ownership of the Corvette.

Dues

All dues and fees are payable to Carolina Corvette Club, Inc. An initiation fee of ten dollars shall be levied upon those obtaining membership. The companion initiation fee shall be five dollars.

- A. Single membership dues shall be sixty dollars per year for Owner Members. Companion dues shall be twenty-five dollars a year. Dues shall be paid by the end of the October meeting for the upcoming calendar year.
- B. In appreciation of the special contributions of Charter Members, the Club confers upon each of them an Active Membership, waives their membership fees and dues, and pays their NCCC dues from the Club treasury.

Communications

The Vice President of the Club will develop, maintain, and distribute a Welcome Package for each Club visitor and new member. The Welcome Package will contain, but is not limited to the following items:

Club Award Points:

The Secretary of the Club will maintain a running total of each members earned points. These points will be used to help determine the winners of the Club's Awards, currently awarded annually. For purposes of earning points a sponsored event is an event that is proposed by a member and requires a simple majority vote at a Club business meeting. A member earns points as follows (actual points earned for a particular event will be determines by the Vice President of the Club):

- A. A member shall receive three points for attending a regular meeting.
- B. A member shall not receive meeting points if the members fails to pay dues by the due date. (For that meeting and all subsequent meetings until the dues are paid. These points shall not be awarded.) The meeting will be considered over when the person responsible for collecting the dues has left.
- C. A member shall receive three points for attending a club event.
- D. A member shall receive NO points for missing an event regardless of reason.
- E. A member shall receive eight (8) points for chairing a large event (such as, but not limited to full day, weekend, rally, banquet), five (5) points to chair a small event (such as, but not limited to a half-day outing, dinner, sporting event, breakfast), but receives no club points for participating in the event.
- F. A member will receive no more than two points for obtaining food; procuring tables chairs, etc. for a club event.
